

BYLAW 2005-15
OF THE MUNICIPAL DISTRICT OF OPPORTUNITY NO 17
In The Province of Alberta

Being a Bylaw of the Municipal District to establish a road closure bylaw creating title to a new registered road plan and consolidating portions of the road in accordance with Section 22 of the Municipal Government Act, Chapter M26.1, Revised Statutes of Alberta 2000, as amended.

WHEREAS, the Council of the Municipal District of Opportunity No. 17 now deems it necessary that the lands hereafter described are no longer required for public travel, and

WHEREAS, application has been made to Council to have a portion of the road closed, and

WHEREAS, the Council of the Municipal District of Opportunity deems it expedient to provide for a bylaw for the purpose of closing to public travel certain roads or portions thereof, situated in the said municipality, and thereafter consolidating the portion to the registered parcels and,

WHEREAS notice of the intention of Council to pass a bylaw has been given in accordance with Section 606 of the Municipal Government Act, and,

WHEREAS Council were not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the bylaw.

NOW THEREFORE BE IT RESOLVED that the Council of the Municipal District of Opportunity No. 17, duly assembled, hereby adopts and enacts the following:

ALL THAT PORTION OF ROAD LYING NORTH WEST OF A LINE DRAWN FROM THE NORTH EAST CORNER OF LOT 4, BLOCK 2, PLAN 9820568 TO THE INTERSECTION OF THE CURVILINEAR SOUTH WEST BOUNDARY (HAVING A RADIUS OF 15.00 METERS) OF LOT 5, BLOCK 2, PLAN 9820568 WITH THE STRAIGHT SOUTH WEST BOUNDARY (HAVING A DISTANCE OF 22.80 METRES) OF SAID LOT 5.
EXCEPTING THEREOUT ALL MINES AND MINERALS
