

BYLAW 2008 - 10

OF THE MUNICIPAL DISTRICT OF OPPORTUNITY NO.17 In the Province of Alberta

To establish the hamlet boundaries for Wabasca, Alberta.

Whereas, Section 59 of the *Municipal Government Act* being Chapter M-26.59(3), *RSA 2000* empowers Council to declare any given area to be a hamlet and to designate its boundaries; and

Whereas, because development is taking place within the outlined area, it is desirable to declare area to be hamlet and to designate its boundaries.

Now Therefore, the Council of the Municipal District of Opportunity No.17 in the Province of Alberta, duly assembled, hereby enacts the following:

1. The lands described in Schedule "A" shall be declared as the Hamlet of Wabasca, Alberta.
2. The boundaries of the Hamlet of Wabasca shall be established as outlined in red on Schedule "B".

ALSO INCLUDED ARE ALL THE ROAD ALLOWANCES AND ROAD ALLOWANCE INTERSECTIONS IN AND ADJOINING THE ABOVE DESCRIBED LANDS.


3. That Ministerial Order 625/87 and Bylaw 2006 - 10 are repealed in their entirety and any other Bylaws applicable to boundaries.
4. That Bylaw 2008 - 10 becomes effective on the date of the third and final reading thereof.
