ALL THAT PORTION OF THE ORIGINAL GOVERNMENT ROAD ALLOWANCE ADJOINING THE WEST BOUNDARY OF 4-25-80-25-NW
EXCEPTING THEREOUT ALL MINES AND MINERALS
