BYLAW 2014-11

Being a Bylaw of the Municipal District of Opportunity No. 17 in the Province of Alberta to designate Lot 1, Block 1, Plan 142 2715 in the Hamlet of Wabasca in the Municipal District of Opportunity No. 17, to Municipal Reserve. In accordance with Section 665(1) of the Municipal Government Act, Chapter M26.1, Revised Statutes of Alberta 2000, As Amended.

WHEREAS the Municipal Government Act, S.A. 2000, Section 665(1) provides that a Municipal Council may designate a parcel of land or a part of a parcel of land as Municipal Reserve;

WHEREAS the Council of the Municipal District of Opportunity No. 17 has determined that it wishes to designate a parcel of land as Municipal Reserve;

NOW THEREFORE the Council of the Municipal District of Opportunity No. 17, duly assembled, enacts as follows.

1. That Lot 1, Block 1, Plan 142 2715 containing a total of (5.05 ha. or 12.45 acres) as indicated in black on the attached Schedule 'A', be designated as Municipal Reserve.
2. Bylaw 2013-06, being the previous Bylaw with which to designate Lot 21, Plan WABISKA as Municipal Reserve, is hereby repealed.

This Bylaw comes into effect upon the date of the final reading thereof


