BYLAW 2025-14

In the Province of Alberta

To Amend Bylaw 2008-10 and Expand the Hamlet Boundaries for Wabasca, Alberta

Whereas Section 59(1) of the Municipal Government Act, RSA 2000, c M-26, empowers Council to designate an unincorporated community that is within its boundaries to be a hamlet; and

Whereas Bylaw 2008-10 of the Municipal District of Opportunity established the boundaries of the Hamlet of Wabasca;

Whereas economic and community development opportunities in the Wabasca region requires the expansion of the Hamlet's boundaries to facilitate anticipate growth;

Now Therefore, the Council of the Municipal District of Opportunity in the Province of Alberta, duly assembled, hereby enacts the following:

1. Bylaw 2008-10 is hereby amended to include all lands identified on Schedule A of this bylaw as part of the Hamlet of Wabasca. These lands are located within the following quarter sections:

Read a second time in Council this 27 day of August, 2025.

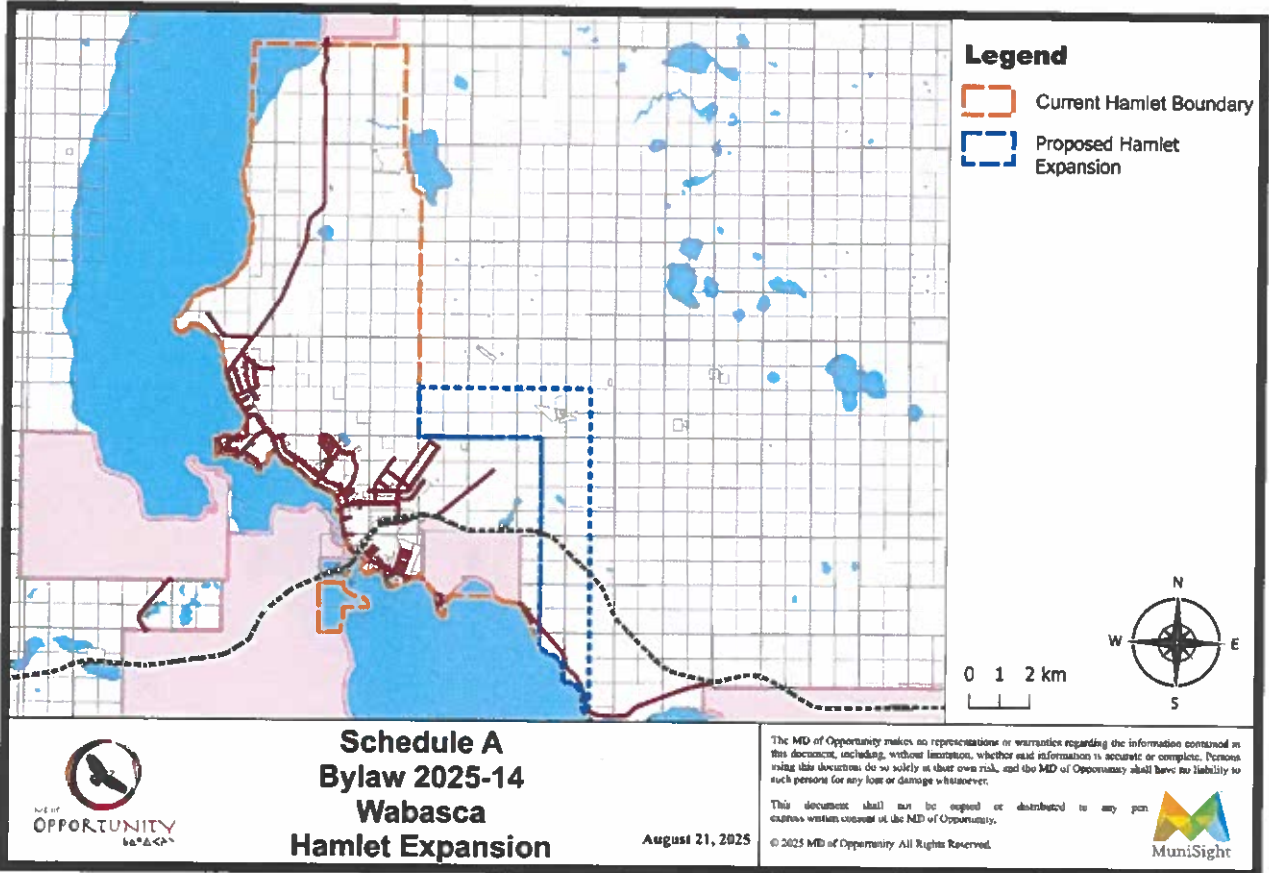
Read a third time in Council and passed this 27 day of August, 2025.

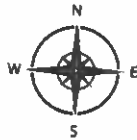
